1. Mastering compliance for studios and performers

Conditions required for studio registration:

- to have minimum one performer activated, before the activation of the studio account
- to provide legible identification documents for studio manager
- to fill in (and justify with documents) all information that we request in the Contract (exemple: Vat Number, Company Certificate etc.)
- to submit a proof of residence (if no company) or all pages of the company's registration certificate, issued by the Ministry of Commerce (if company) in order to confirm residence address.
- the proof of residence (if no company) or all pages of the company's registration certificate, issued by the Ministry of Commerce (if company), must be in 3 months validity. If company certificate is older than 3 months, the manager must send also a certificate issued by the Finance Minister with minimum 3 months validity of the document (Certificate of Incorporation / Certificate of Incumbency/ Certificate of Good Standing

Documents required for studio registration:

- photo with proof of Identity recto-verso (national ID card, passport, driving license)
- selfie via online verification tool (or photo with proof of identity next to the face via Classic Lane)
- photo with proof of residence or company certificate
- if company certificate is older than 3 months, the manager must send also a certificate issued by the Finance Minister with minimum 3 months validity of the document (Certificate of Incorporation / Certificate of Incumbency/ Certificate of Good Standing etc.)

1. Mastering compliance for studios and performers

Proof of Identity accepted (it can differ, depending on the country of provenance) :

- ➔ Passeport
- ➔ ID Card
- ➔ Driving license

The photo of the ID must be legible, without visible alteration :

- ✓ The ID card must be the original (all borders visible) not a scanned copy / xerox copy
- ✓ The ID must mention the last name and first name, the birthday, the nationality of the applicant, as well as the expiration date of the document (if the id card has an expiration date)
- ✓ No identification documents that has passed the expiration date will be accepted.

Here is a list of proof of address (scanned copies of electronic bills are accepted):

- An electricity invoice
- A water invoice
- A gas invoice
- A telephone invoice, cell phone invoice or internet subscription
- A tax notice issued by the tax authorities
- An insurance certificate or invoice for the accommodation you live in
- A rent contract
- A property deed


Attention: Proof of residence or company document are mandatory and must be: on the studio owner's name, on the same postal address as the address that manager filled in contract and with 3 months validity term.

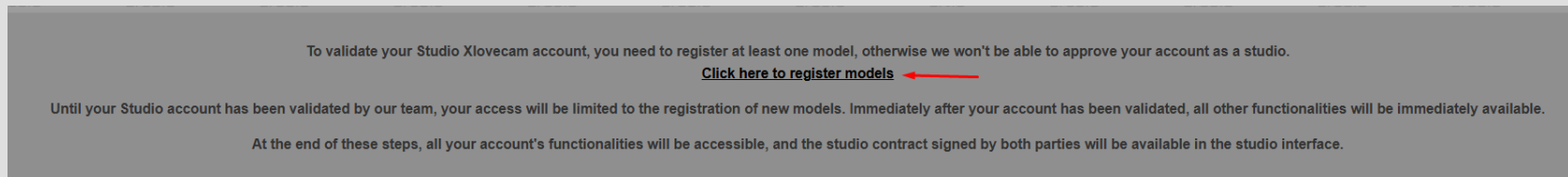
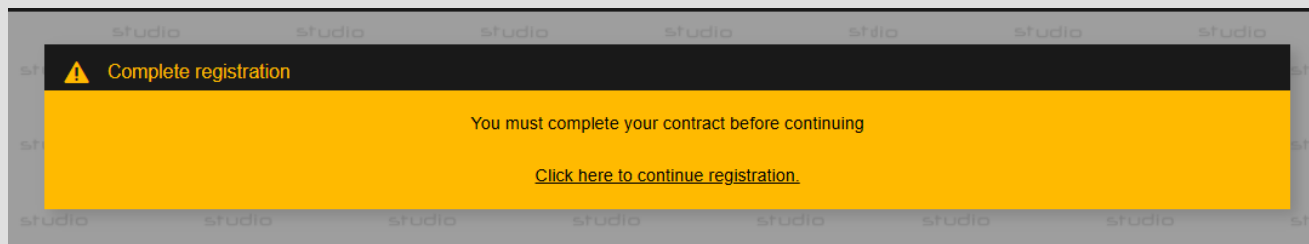

*In both cases, after clicking on the button “Complete registration”, you will be redirected automatically on your studio account.
You will see two messages on your home page :*

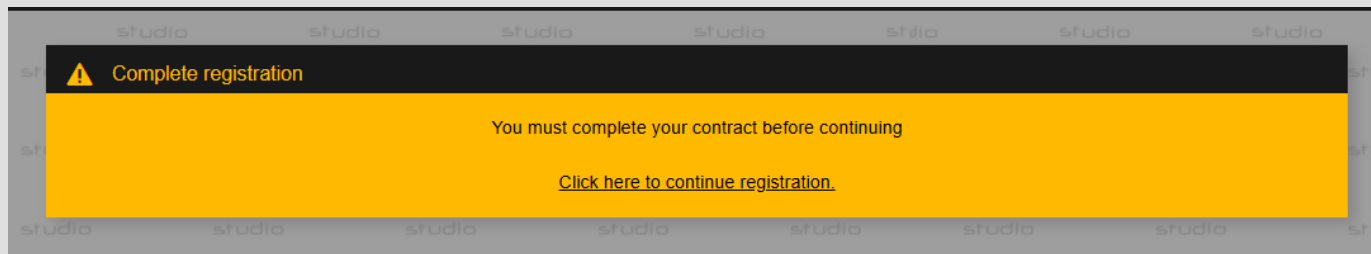
- 1. ”You must complete your contract before continuing” → Click on “Click here to continue registration” to complete your studio registration.*
- 2. ”To validate your Studio Xlovecam account, you need to register at least one model..” → Click on “Click here to register models” to start adding models to your studio account.*

1.1. Steps to create a studio account

To complete your registration as a studio, you must first register a performer account under your studio, as we have previously discussed. After you have successfully registered a performer, proceed with your studio registration. Click on “Click here to continue registration”.






In the next step, you'll be asked to complete the contract, to make the online verification or to upload the identity documents/company documents.





1.1. Steps to create a studio account

Fast Lane Method : in some cases, this could be the only way to make the identity verification.

To start with the online identity verification, click on the button “Start the verification”.

Fast Lane Method : we highly recommend this **online identity verification method** to complete your registration process because **is faster and safer**. The system performs automated checks that lead to **quicker onboarding**.


This method allows you to complete registration **without Mistakes**, as the system automatically take data from your ID card and completes the **contract**. Therefore the whole onboarding process becomes simpler, faster and avoids mistakes.

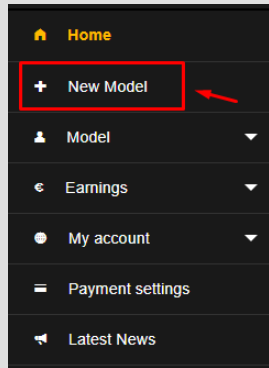



2. Onboarding models into the platform

Step 2

Complete the registration form with performer's personal information. Even if some information is marked as optional, in fact it's mandatory to complete Street number, Street name, additional address and also telephone number. You can complete with studio's full address and studio manager's phone number. Click on "Next" button after you have completed. The next step requires you to choose "Save and create", meaning that you will save this registration and create another one for another model or "Complete registration" to complete the current performer registration that you have just created.

Registration being verified by our specialized team. You will be contacted by e-mail with further updates. Usually the procedure of verification and approval can take between 24-48 hours.

2.2.The most common mistakes during the onboarding process

1.a.Incorrect legal name in contract

Example: on id card Last Name : Martinez

On the contract completed : Martines → which is wrong. You must complete with the correct legal name, as it is indicated on the identity document.

7. ID card/passport next to the face - not legible (the resolution must allow to read the information from the document)



2.2.The most common mistakes during the onboarding process

8. Multiple account : if model has already an active account at the same studio, the new one cannot be accepted.Please user her active account.

9.Couple account: the documents/personal information must be completed in the right place for each model.

For example, we have a couple account formed by a woman and a man.There had been cases where, by mistake, the man's contract has been completed with the data from woman's documents.

2.3.Exceptions Onboarding

In what conditions a performer will not be accepted on the platform :

- is a minor, or looks too young
- false identity document
- expired identity document
- broke too many times, the platform's guidelines
- tried to fraud the contest's system
- already an active account :

1.The performer is having an active account at another studio then :

- If the performer had recent private shows,she can close her account, but the studio owner must send us an e-mail with a photo of his/hers identity card, and give his/her approval for her, to open a new account; otherwise the performer will wait 3 to 6 months(depending on the case) for the validation of the new account.

- If the performer didn't had recent private shows, she can close her account, and the new account at another studio will be approved.

2. The performer is having an active independent account then:

- She can close her account, and the new account at the studio will be approved.
- She can also send us an e-mail with a photo of her identity card, and to request the account's closure.

2.4. Why Onboarding Matters

The way you interact with new models and how you onboard them, really matters.

Here's a few things that you should take into consideration:

- First 30 days = most models might either quit or succeed*
- Confused or unsupported models disappear quickly*
- Studios with **onboarding** systems retain 2–3x more performers*

2. The Studio's Role: From Application to Activation

Steps:

- Model fills out studio form or DMs the studio*
- You must explain requirements (ID, age, etc.) : legal age in the country of provenance, accepted ID (national identity card, passport, driving license).*
- Studio registers the model on XLoveCam and uploads documents*
- Model gets access to platform – Day 1 begins*

3. Day 1–7: Foundation Building

Setup & Orientation

- *Profile photos, gallery photos, videos (soft&hard), bio page, personal space , welcome message to new fans, setting prices, activating VIP.*
- *Room setup: lighting, camera angle, outfit guidelines*

Offer Basic Platform Training

- *Model interface tour*
- *Explain the concepts Free vs private chat*
- *How to stay online correctly*
- *Platform's Rules (exchange of personal information, minors, zoophilia, incest, asking money, poo etc)*

Talk about Account & Security

- *Password safety : explain why is important not to share login information with nobody*
- *Performer account login*
- *How to recognize scams/phishing*

Offer Emotional Support

- *The model might be shy, nervous, or overconfident*
- *Be available — daily check-ins in the first week*

4. Week 2–4: Building Habits & Performance

Performance Review Every 7 Days

- Time online
- Earnings
- Conversion (free to paid)
- What they did well / what to improve

Coaching by Goals

- Set targets (e.g. 15h/week, 5 new clients/day)
- Reward progress (small bonuses, encouragement, shoutouts)

Advanced Tools Intro

- Room titles
- Promotions
- Top client follow-up
- Use of toys/Actions Panel/Timeline

Shift to Independence

- Less hand-holding, more self-responsibility
- Encourage initiative: custom shows, creating content

5. Training Tools, Templates & Mistakes to Avoid

Tools to Use:

- Onboarding checklist (print or Google Doc)
- Model Welcome Guide (PDF)
- Pre-recorded training videos (interface walkthrough, tips)
- Schedule calendar (Google Sheets or whiteboard)

Mistakes to Avoid:

- Overloading the model with technical stuff on Day 1
- Leaving them alone on first login
- Ignoring their emotional state (“am I doing ok?”)
- Not explaining WHY some things matter (e.g. uploading content, having conversations with everybody including guests/visitors, schedule)

If you follow all these suggestions, I am sure that you will retain more performers in your studio.
